The door is obscured by a wood screen door. There are replacement wood steps and hand railings; the bottom two or three steps are concrete. It consists of a full-width porch with slightly battered posts sitting on a railing made of the same siding as the house The porch is sheltered by a secondary hipped roof. The door is the original Craftsman door with six lights. There are concrete steps and a wood board landing and wood hand railings. There is a secondary entrance on the west side for another apartment. There are three windows on the façade. They are asymmetrically spaced and consist of an aluminum slider and two double-hung sash windows, all within the porch. Other windows throughout the residence consist of a combination of aluminum sliders and double-hung sash windows. Some are the original wood windows modified to have window air conditioners.

The apartment building at 204 C Street in Yuba City was constructed in 1921 in the Spanish Colonial Revival style. Today it houses the Sutter County District Attorney/Victim Witness Offices. The building is at street level, on the south side of C Street between Second Street and Courthouse Way. The building faces north within a neighborhood consisting of single-family residences built primarily between the 1860s and the early twentieth century, as well as county government buildings.

This is a two-story apartment building with a rectangular floor plan. The façade is symmetrical and the building sits on a concrete foundation. The building has a wood-framed structural system and an exterior clad in smooth stucco. The base of the elevations are clad with bricks laid in a stretch course with a band of bricks laid vertically above. The building is covered by a low-pitched pyramidal hipped roof clad with wood shingles. The moderate to wide overhanging eaves have regularly-spaced single brackets. The building has two concrete chimneys with brick located on the south section of the roof. The house also has rain gutters.

The primary entry is at the façade. Brick steps and landing with metal handrails lead to the entry surrounded by engaged Doric columns. There is an entablature above engraved with "Las Plumas." There is a metal and glass door flanked by ribbed sidelights. A door at the center of the second floor level is wood with eighteen lights, opening out onto a metal balconet. There are four windows on the façade. Each window has four wood casement-style sashes, each with eight lights. There are rosette medallions located within arches just above the center of the two first floor windows. Other windows throughout the apartment building consist of a combination of original wood casement windows with either six or eight lights per sash. The west and east elevations have two-story bay windows. The window at the bay window of the west elevation and a few at the south (rear) elevation have been replaced. The horizontal bands that go around the building just below the windows also create a hooded frame around the second floor door.

Landscaping elements include bushes and flowers planted in beds directly adjacent to the building. Other features include an asphalt paved driveway located directly to the east.

Alterations to the building include re-stucco of the building (although the texture appears to remain the same or similar), replaced front door, sidelights, steps and handrails, and replaced windows at the west and rear elevations. The condition of the building is good.

The single-family residence at 212 C Street in Yuba City was constructed in 1874 in the Carpenter Italianate style. It is currently operated as a Bed and Breakfast and residence. It is on the south side of C Street between Second Street and Courthouse Way and faces north within a residential neighborhood. This building is known as the Harkey House.

This is a two-story L-shaped residence. The façade is asymmetrical and the building sits on a concrete and brick foundation. The residence has a redwood-framed structural system and an exterior clad in redwood siding. The main house is brick. The building is covered by a steeply-pitched cross-gabled roof clad with steel tiles made to look like Spanish tiles. The moderately-overhanging eaves are supported by paired brackets. There is a return on each of the gables. The façade gable has a vent with a gabled hood that is flanked by two smaller rectangular vents. The west elevation gable has a rectangular vent. There are quoins on each corner of the home. The residence has one interior chimney located on the slope.

The primary entry is located at the facade. It consists of a full-width porch supported by four rectangular wood columns sitting on rectangular wood bases. The porch has a balustrade and brick steps lead up to a brick landing. The wood paneled front door and screen door are original. The etched glass side lights and transom are also original. The recessed entry has paneled wall surfaces. There are six windows on the façade. They are symmetrically spaced and consist of double-hung wood-sash-type windows. The double-hung sash windows with two lights per sash at the front door are original. The second floor windows were replaced in the early 2000s. The sun room/breakfast room windows on the west elevation were installed in 1984. The windows came from the now-demolished Marysville High School. The windows on the main section of the façade have window surrounds with hoods with small details. The east elevation has a two-story bay window clad with wood fishscale-type shingles. Most of the windows on the east elevation were boarded up in the 1950s. The current owners installed the shutters. Some of the other windows on the secondary elevations have been replaced.

Landscaping elements include a small front lawn, shrubs and small plants in a bed directly adjacent to the front of the house. There are two squat concrete posts flanking the concrete pedestrian entry to the front porch. There is a metal gate accessing the back yard from the concrete driveway/carport. A low concrete border surrounds the front of the property. Other features include a concrete driveway located to the east of the residence, leading to a carport constructed in 1975. The pool was also installed that year. The deck was put in the back yard in 1980. A brick patio was put in the back yard by a previous owner between 1955 and 1968. There is a one-story shedroof section on the rear elevation. The southeast section of the rear addition was added in the 1940s. There are two additions at the second story rear. The one at the east side was installed in ca 1930s-1940s and began as a sun/laundry room and is today a bathroom. The addition on the west side of the rear second floor was constructed in 1990 and is a bathroom. There is a guestroom at the rear of the property installed in 2002.

The condition of the building is excellent to good. Alterations to the building include the sunroom screens which have been replaced with windows from Marysville High School, some replacement windows and some additions at the rear from the 1940s to present. The front porch bricks were likely installed in the 1950s.

# The Old Harkey House

William Pinckney Harkey, born in Illinois in 1823, the son of Solomon Harkey, was the eldest of nine children. As a very young man he made a living "teaming," but in 1854 at age 22 he started west with a wagon and a team of mules. He stopped briefly in St. Joseph, Missouri, where he was married; then he continued on to Marysville. There he began teaming and freighting supplies to the mines (charging 3½ to 5 cents a pound). Eventually he was able to purchase squatter's rights to farm land in Yuba County, where he grew grain; later he sold this property for a good profit. In 1867 he purchased land in Sutter County and raised stock and grain. Soon he owned 1,600 acres. This property was called Harkey's Corners. A picture of his first house can be found in Thompson and West's *History of Sutter County*.

Harkey was elected sheriff of Sutter County in 1873. Since he chose to live near the Courthouse, in 1874 he constructed a house of simple classical design at 212 C Street. The balustrade veranda, the hipped roof, quoined corners, and tall pedimented windows with shutters gave the house a graceful, balanced façade.

In 1904 Mr. and Mrs. Harkey celebrated their fiftieth wedding anniversary with an "at home" party, a very festive occasion lasting all day. Mrs. Clarinda Harkey outlived her husband for twelve years. When she died in 1920, she willed the house to her granddaughter, Ida Idylene Campbell Kuykendall, who sold it to Mrs. And Mrs. Oscar Lanzendorf.

Mr. and Mrs. Sid Smith bought the house in 1955. It has recently become the residence of Mr. and Mrs. James Liminoff. Throughout the years it has been carefully preserved and loved, and it shows!

The single-family residence at 218 C Street was constructed in 1905 in the Queen Anne style. It is on the south side of C Street between Courthouse Way and McRae Way and faces north within a residential neighborhood near the Sutter County Courthouse and government offices.

This is a one-story residence with a nearly rectangular floor plan. The façade is asymmetrical and the building sits on a concrete foundation. The residence has a wood-framed structural system and an exterior clad in what appear to be asphalt shingles. The building is covered by a moderately-pitched pyramidal hipped roof clad with composition shingles. The moderately-overhanging eaves are boxed with a rectangular vented opening located in the front gable as well as a slanted section below clad with composition shingles. The residence has one exterior brick chimney located on the eave wall.

# \*P3a. Description:

The primary entry is located at the facade. It consists of a partial-width porch supported by two round columns. Wood stairs and low wood shingle handrails lead up to a wood landing. The wood and glass front door has a Victorian look but the screen door is not original. The porch is located above a raised basement. A flat roof shelters the porch area and there is a wood railing surrounding the top edge.

There are four windows on the façade. They consist of double-hung wood-sash windows with lambs tongues. There is a bay window located at the east section of the façade. Its windows have a single sash below and 84 lights on the upper sash. The double-hung sash window within the porch is a vinyl replacement. Its shutters are also not original. Other windows throughout the residence consist of a combination of double-hung sash windows. Those at the bay window on the east elevation have the same single sash with one light below and an upper sash with multiple lights above.

Other elements of this residence include a metal light fixture at the porch.

Landscaping elements include a lawn with shrubs and small plants directly adjacent to the home. There is a colonial-style 1950s light post on the lawn. Other features include a concrete driveway leading to a white picket fence and carport located in the back yard to the southeast of the house. A red brick pedestrian walkway leads to the porch from the sidewalk and also to the driveway. Concrete low squat pots flank the beginning of the walkway and a low concrete border is located at the front of the property.

The condition of the building is good. Alterations to the building include what appears to be asphalt exterior shingles, new windows within the porch, installation of a railing above the porch roof and a screen door and shutters within the porch area.

The single-family residence at 221 C Street in Yuba City was constructed in 1916. It is designed in a Colonial Revival style with some Craftsman elements. It is located on the north side of C Street between Second Street and McRae Way and faces south within a primarily residential area with buildings from the 1870s to 1950s. Courthouse Way and the Sutter County Courthouse are to the immediate east.

This residence is two-stories, with a nearly rectangular floor plan. The façade is symmetrical and the building sits on a concrete foundation. The residence has a wood-framed structural system and an exterior clad in wood shingles on the second floor and smooth stucco on the first floor. The building is covered by a moderately-pitched side-gabled roof clad with composition shingles. The wide overhanging eaves are open with exposed rafters. The residence has one exterior chimney located on the north elevation.

### \*P3a. Description:

The primary entry is located at the façade. It consists of a porch sheltered by a dropped-gabled secondary roof with wide verge boards and exposed rafters. The porch roof is supported by squared wood porch supports. The entry door appears to be a wood door that is partially obscured from view by a metal security door and the porch steps and landing are concrete. The porch railing is wood-framed clad in stucco. Other entrances could not be observed. There are eleven windows on the façade. They are asymmetrically spaced and consist of double-hung vinyl-sash windows with wood casings and sills. Other windows throughout the residence consist of double-hung vinyl-sash windows with wood casings and sills. There is a projecting section on the west elevation that appears to have double-hung vinyl-sash windows and a row of nine vinyl-sash windows on the east elevation of a sunroom.

Other elements of this residence include wood shingles under the porch roof gable pitch and a basketweave-patterned vent under the east elevation gable pitch.

Landscaping elements include a front lawn, a mature tree, four relatively young trees and some young shrubs. Other features include a shed near the north elevation, a concrete walkway leading from the sidewalk to the main entrance and a porch light.

The condition of the building is excellent to good. Alterations to the building include the replacement of windows and the possible recladding of the first floor exterior.

The single-family residence at 223 C Street in Yuba City was constructed in circa 1890-1900 with Colonial Revival and Queen Anne features. It is on the north side of C Street facing south within a residential area.

This is a two-story residence with what appears to be a square floor plan. Neither the façade nor the foundation is visible. The residence has a wood-framed structural system and an exterior clad in horizontal wood siding. The building is covered by a moderately-pitched hipped roof clad in composition shingles. The slightly-overhanging eaves are boxed with a wood course that surrounds the building at the roofline. A gabled dormer is on the east elevation. It is clad with fishscale shingles and has a rectangular metal attic vent and a small truss. A brick chimney is visible on the east roof's slope.

The single-family residence at 224 C Street in Yuba City was constructed in circa 1874 in the Italianate style. It is located on the south side of C Street between Courthouse Way and Mc Rae Way and faces north. The residence is set back about ten feet from C Street and is on the southeast end of the parcel.

This is a two-story residence. The original building is square. The façade is asymmetrical and the building sits on a foundation that is not visible. # \*P3a. Description:

The primary entry is located at the façade. It consists of a porch with a secondary flat roof with a pediment detail in front. Two rectangular columns support the porch. There are brick steps and a brick landing leading up to the wood paneled door. There is a metal handrail. It has a wood screen door and transom window above. There is a circa 1970s light fixture hanging under the porch. The rear entry could not be accessed.

There are nine windows on the façade. They are symmetrically spaced and consist of double-hung wood-sash type. They have window surrounds including a pedimented hood. The two first story windows at the northwest end were replaced in the circa early 1970s by single-light fixed tinted windows. Other windows throughout the residence consist of a combination of original double-hung wood-sash windows on the second floor with replacement fixed tinted windows on the west elevation first floor. There is a two-story bay window on the east elevation.

Landscaping elements include an extensive lawn located in front of the residence, which is set back about 100 feet from the sidewalk. There are shrubs and other vegetation located within beds directly adjacent to the front section of the façade. Other features include a circa 1970s coarse aggregate wide pathway leading to the front porch. The pathway also extends to the rear of the property and the asphalt paved drive. There are additions to the west: a glass enclosed 1970s addition directly to the west, followed by a circa 1971 addition, and a 1990s addition.

The condition of the building is excellent to good. Alterations to the building include the construction of additions.

# **Stabler-Swinson House**

Like the majority of early homes in the Yuba city area, the Stabler-Swinson House, built in 1862, is of Italianate design. The outstanding features of this house are the graceful brackets supporting the roof and the rich trim forming a frieze around the top of the building. The present owners, Mr. and Mrs. Coburn Haskell, have added onto the original house without destroying the feeling of its past. The new wing has used the same cornices on the windows, and the corners are quoined to match the old. It is "a large Italianate house with a modern Italianate porch-and-office addition connected by an International style corridor. It comes off very well."<sup>1</sup>

"The land on which this residence stands was a part of the estate of Judge R. B. Sherrard, County Judge of Sutter, who died in 1860. The land was purchased from the estate in 1861 by Samuel J. Stabler, who had recently moved to Yuba City from Maryland and who was serving as county clerk and recorder. Stabler paid the estate \$180.00 for about two and a half acres, an irregular piece at the corner of Second and C Streets, running west on C for 782 feet and south on Second for 184 feet.

"Stabler built the present residence between 1862 and 1867 and lived here the next twenty years. During this period he sold the frontage on Second Street, keeping a lot of 200 feet on C with a depth of 184 feet, the lot containing the house.

"In 1887 Stabler sold the residence to Robert C. and Harriet Kells for \$3500.00 The Kells kept possession until 1899, when they deeded the property to the Farmers' Cooperative union for \$2450.00 The Farmers' Union was conducting a banking business at the time, and this last conveyance was probably made to satisfy a loan.

"Three years later, in 1902, the Farmers' Union sold the house to Lutie Schillig, the wife of Bennet Schillig, for \$2050; but in 1900 the lot had been reduced to 148 feet on C Street by the sale of 52 feet on C Street to Lawrence Schillig for \$275.

"The property remained in the possession of the Schilligs for thirty years or more. In 1944 Lowell O. Gibson, who had acquired it, sold it to Manuel S. Oliver of Alameda for \$5500. Then in August of the same year Oliver deeded the house and the lot, now 148 by 184 feet, to Verne D., K. Deane, and Marie I. Swinson."<sup>2</sup>

From *In Focus: News for the Residents of Yuba City* April 2001 page 2 "Stabler-Swinson House Sparkles on C Street"

Samuel I. Stabler has lent his name to a busy Yuba City Street and one of the area's most beautiful examples of Italianate Architectural design.

Stabler, born in Maryland, joined the rush to California in 1850. He landed in San Francisco in 1850, spending three years as a merchant and auctioneer before heading for the mining areas in El Dorado and Sierra Counties, finally settling in Yuba City in 1860.

In 1861 he purchased the land on which the Stabler-Swinson House stands from the estate of Judge R. B. Sherrard for \$180. Stabler built his commanding two story home at 224 C Street between 1862 and 1867. He and his wife Alice lived in the house for 20 years.<sup>3</sup> They had three children: Henry, Kate and Marguerite.

The courthouse was a short walk from his new residence. The location was ideal for the politically active newcomer, who successfully ran for District Attorney on the Democratic ticket and served two terms. His son was later elected to the California Assembly.

Stabler was the senior member of the law form of Stabler and Bayne, which had offices in Yuba City and Colusa. A businessman as well as an attorney and politician, Stabler was also a member of the Sutter County Board of Trade.

Stabler left the area for a short time for health reasons, but returned to settle on a 208 acre ranch he owned. After experimenting with fruit trees he pulled more than 100 acres of peach trees to plant the more profitable Thompson seedless grapes. He also built a dryer and warehouse on the property, drying both his and his neighbors raisins.

Stabler sold the family home, which he had sub-divided out of the original property, to Robert C. and Harriet Kells for \$3,500 in 1887. The Kells owned the house until 1899 when the property was deeded to the Farmers' Cooperative Union for \$2,450.<sup>4</sup> The Cooperative was in the banking business during this time and it is assumed the conveyance was to repay a loan.

The value of the prestigious home continued to stay below the price Stabler received for the original sale to the Kellses. The bank sold the home to Lutie Schillig, wife of Benet Schillig, for \$2,050. Like Stabler, the Farmers' Union cut a piece of property from the home place before selling it to Mrs. Schillig. The original property had shrunk from a two and one-half acre estate to a lot with 200 feet frontage on C Street with a depth of 184 feet.

The Schilligs kept the property for 30 years, when the house was sold to Lowell O. Gibson who re-sold it for \$5,500 to an Alameda resident, Manuel S. Oliver. During this period the land surrounding the house was reduced even further, as the lot Oliver deeded to Verne D. K. Deane and Marie I. Swinson was now 148 feet by 184 feet.

Later owners made several changes to the house and adjacent property. Coburn and Dodo Haskell added a wing. They carefully maintained the feel of the original house by using the same cornices on the windows, and corners are quinoid to match the original house. The large Italianate house now has a modern Italianate porch and office addition.

The late Dodo Wood later opened the first version of her Pacific Wildlife gallery in the new addition. The gallery was later moved to Colusa Avenue after Ms. Woods sold the home to the current owners Richard and Betty Arnoldy.

The Arnoldys have strived to maintain the elegance of the house and grounds that Samuel Stabler built.

The primary entry is located at the façade. It consists of a porch sheltered by a dropped secondary roof supported by squared wood columns with wood shingle cladding on the bases. The balusters are wood, the porch steps and landing are red brick and the hand rails are metal. The entry is recessed and the door is wood. Other entries could not be observed. There are ten windows on the façade. They are asymmetrically spaced and consist of a squared bay window on the right side that has two double-hung wood-sash windows. Within the front porch is a fixed wood-sash window with wood casing and wood sill with brackets below the sill. The second story façade has two double-hung wood-sash windows with diamond-shaped upper panes and a wood sash diamond-shaped fixed window with multiple panes. There is an attic window with stained glass above the squared bay window. Other windows throughout the residence consist of a combination of wood sash windows, double-hung windows with two upper panes topped by pediments and double-hung wood-sash windows with two panes.

Other elements of this residence include numerous carved wood brackets underneath the first story windows, stylized motifs and paneling on the squared bay windows, fishscale wood shingle siding, a sun ray design under the gable end of a secondary roof that covers the bay window, and a wood vent under the second story gable.

Landscaping elements include a front lawn, mature evergreen tree, Camellia tree, citrus trees, and mature oleander plants bordering the east side of the property. Other features include a concrete driveway that leads to a detached six-car garage. A concrete walkway leads from the sidewalk to the main entrance and to the east side of the house.

The condition of the building is excellent. Alterations to the building include the addition of large shed-style dormers and an addition to the rear.

The evaluated building is located at 405 Center Street in Yuba City, Sutter County. It is located on the north side of Center Street between Shasta and Plumas Streets. It is located approximately 1.2 miles each of Hwy 99 and less than 0.5 miles west of the Sutter-Yuba County border. The topography of the area is flat.

This building is a two-story commercial building constructed in 1955 in the Modern style. It has a rectangular floor plan and the southeast facing façade is asymmetrical. The foundation is concrete. The building appears to be poured concrete. It is covered by a flat roof clad in rolled composite sheets with a squared centrally-located parapet. There is a metal balcony attached to the second floor of the northwest elevation. The main entry, located near the center of the façade and sheltered by a canvas roof, consists of two non-original metal and glass doors. Other entrances are located on the southwest and northeast elevations and consist of what appear to also be metal and glass doors. There are a total of twenty-eight windows on the façade, which are symmetrically spaced and consist of metal casement windows. The second floor windows are framed by concrete borders and the center windows with the second-story windows framed by concrete borders on the northeast elevation and it appears that the windows on the other elevations have been sealed. Decorative elements include metal casement windows with second-story windows framed by a concrete border, and a squared centrally-located parapet with decorative geometric grooves. The building fronts Center Street and is set back behind a sidewalk. It appears that there are no ancillary buildings on the property. Alterations to the building include the following: replacement of the façade entry doors, the elimination of windows on the southwest and northwest elevations, and the attachment of an extended canvas awning to the façade.

The Modern style was popular in California from the 1930s to the 1950s. Typical character-defining features of the Modern style are poured concrete walls, metal casement windows framed by a concrete border and a flat roof. This building has retained most of its character-defining features, which include poured concrete walls, metal casement windows with second floor window concrete borders and a flat roof with a squared centrally-located parapet. This building is a one-story vernacular building constructed in 1941. It has a rectangular floor plan and the southeast facing façade is asymmetrical. The foundation is concrete. The building has a wood structural system clad in a combination of red brick and textured stucco. The building has a flat roof clad in rolled composite sheets with a mansard roof clad in wood shingles extending at the façade; there are two signs attached to the mansard roof. The main entrance is located on the west side of the façade and is sheltered by the mansard roof and the entrance itself consists of a metal-framed glass door flanked by two metal-sash fixed windows. There do not appear to be entrances on the rest of the building. There are two sets of windows on the façade. sections; the entrance is also framed by a secondary wood border with decorative wood brackets. The main entrance to 417 Center Street consists of a slightly recessed entrance with a wood paneled door. Other entrances are located on the southwest and northwest elevations and consist of a wood and glass door and roll up garage door on the southwest elevation and a metal door on the northwest elevation. Two bay windows are located on the façade for 421 Center Street that have wood paneled bases and are topped by a pitched three-sided roof clad in wood shingles. Other windows include square fixed metal-framed windows on the façade of 417 Center Street and a fixed window on the southwest elevation that are covered by security bars.

Decorative elements of this building include horizontal wood board cladding on the façade, a parapet with a cornice and dentils, an entrance topped by a broken triangular and segmental pediment flanked by wood paneled sections and Colonial Revival style bay windows.

The Colonial Revival style was popular in California from 1900s to through the 1950s. The character-defining features of this style include: cornices with dentils, horizontal wood board siding, wood-sash double-hung windows and a wood paneled entry door topped by a pediment, and bay windows with a wood paneled base and topped by a pitched roof clad in wood shingles. This building has the following character defining features: a parapet with a cornice and dentils, horizontal wood board siding, an entry door topped by a broken triangular and segmental pediment, and bay windows with a wood paneled base and topped base and topped by a pitched roof clad in wood shingles.

The condition of the building is good. Alterations to the building include the possible replacement of the horizontal wood siding and the modification to the façade windows of 417 Center Street.

This one-story vernacular commercial building was constructed in circa 1958. It has a rectangular floor plan and the southeast facing façade is asymmetrical. The foundation is concrete. The building has a concrete block and wood-framed structural system clad in textured stucco with geometric scoring on the facade. It is covered by a flat roof clad in rolled composite sheets. There is a carport near the northeast elevation. On the west side of the façade there are two large glass panes with a metal sash and a metal center division. There does not appear to be any windows on the rest of the building. The main entrance is located underneath a fabric awning on the west side of the façade and consists of two metal-framed glass doors topped by a rectangular metal-sash fixed window. A rectangular back-lit sign has been attached to the building above the fabric awning. Decorative elements of this building include geometric scoring on the façade stucco surface. The building fronts onto Center Street and is set behind the sidewalk level. There are no ancillary buildings on the property. There is a paved area near the northeast elevation.

The primary entrance is located beneath the porch. This partial-width porch is sheltered by a secondary gabled roof with a broken pediment and is supported by two Doric columns. The porch landing extends the width of the façade and is concrete. The front door is a Craftsman-style wood-framed door with large glass insets. The door is flanked by two sidelights. There is one pair of windows on the north end of the façade. They are double-hung wood-sash windows with wood and brick sills. Windows on the other elevations consist of double-hung wood-sash windows and wood sills.

Landscaping elements include patchy grass, mature rosebushes, and other flowering shrubs. A detached garage, which has been converted into living space, is located northwest of the residence. A concrete walkway leads from the sidewalk to the front entrance and a concrete driveway is located along the northern border of the parcel.

The condition of the building is good to fair. Alterations to the building include the removal of the original siding and the conversion of the two-car garage.

This is a one-story single-family residence with an irregular floor plan. The façade is asymmetrical and the residence sits on a concrete foundation. The residence has a wood-framed structural system and an exterior clad in smooth stucco and half timbering and horizontal wood siding beneath the roof gables. The building is covered by a steeply-pitched cross-gabled roof with two front facing gables clad with composition shingles. There are no overhanging eaves. The building has one brick chimney on the north gable wall and a second chimney on the southern end of the roof slope. Three round attic vents are located beneath all visible roof gables.

The primary entrance is located beneath a secondary shed roof. It appears that the porch was once open and has now been covered with a metal awning. The landing and steps are not visible but the balustrade is brick. The front door is also not visible but appears to be an iron security door. A second entry is located on the south elevation and consists of a single wood door with a glass inset and a metal awning over the entrance.

There are five windows on the façade. Two windows are located beneath the metal awning. They are a pair of six-over-one light double-hung wood-sash windows with wood sills. There is a multi-light fixed wood-sash window with a geometric design next to the front door. A wood-sash picture window is located on the northern end of the façade beneath a gable with half timbering. The fifth window is located under the southern gable with a six-over-one double-hung wood-sash window with wood sills. Windows on the other elevations consist of a combination of six-over-one double-hung wood-sash windows with wood sills and aluminum-sash sliding windows.

Landscaping elements include mature grass, trees, and shrubs. There is a concrete driveway on the southern section of the parcel and a concrete walkway that leads from the driveway to the front entrance. A detached two-car garage is located southwest of the residence. It is a one-and-a-half story garage and it has a single door on the second floor with no clear access (no stairs or landing). The door is a single wood door with a single glass inset.

The condition of the building is good. Alterations to the building include the addition of metal awnings over the front entrance and side entrance, and the removal of some original windows.
